## Call for abstracts

# Transport Infrastructures for better Accessibility, Equity and Territorial Cohesion

### 20-21 October 2016, Warsaw, Poland

It is our pleasure to invite all NECTAR members for the joint meeting of Cluster 1 (Networks) and Cluster 6 (Accessibility) which will be held in Warsaw in the fall 2016. The conference will bring together leading researchers and practitioners from Europe and elsewhere. The location of the meeting in Warsaw will be a great opportunity to engage researchers particularly from Central and Eastern European countries into NECTAR activities. We believe that it will be a great possibility to share and exchange latest knowledge and experiences in the field of accessibility and transport analyses.

During the last decade Poland has experienced an enormous development of transport infrastructure: newly built motorway sections, modernized railway lines and several investments into public transport infrastructure, including e.g. bike-sharing systems. Other countries of the region have followed similar path of development. It creates a 'real laboratory' to investigate a complex relations between transport infrastructure development and accessibility issues, including their impact on equity and territorial cohesion. However, such a huge 'big push' to transport infrastructure development is also challengeable, especially in terms of a proper evaluation of implemented or planned investments (i.e. both, ex-ante and ex-post evaluation). Gaining from the experience of the countries that had already faced the similar challenges may only be valuable, especially when defining opportunities and threats (best practices and risks, related to, e.g. overinvestment).

- Accessibility in decentralized / centralized regions
- Optimal locations
- Multimodal transport systems

#### **Abstract submission**

Abstracts consisting of no more than 500 words, 3-5 keywords, and the authors' names and affiliation should be sent as .doc(x) or .pdf files by email to Marcin Stepniak (stepniak@twarda.pan.pl) by 30<sup>th</sup> June 2016. The notification of abstract acceptance will be distributed by 14<sup>th</sup> July 2016. The Organizing Committee invites researchers of any level or background, including PhD students, to present finished papers or papers still in progress. Criteria for acceptance are scientific quality of the abstract and NECTAR membership. Selected papers are planned to be published in a special issue of the European Transport Research Review journal.

#### **Fees**

Meals and accommodation for one night will be offered to 25 NECTAR-members, for only one author per paper. NECTAR membership for the year 2016 is required in order to attend the meeting. To become a NECTAR member, visit: http://www.nectar-eu.eu and go to the Membership section.
