Call for papers for the thematic session of Cluster 1 - Transport Infrastructure Impacts and Evaluation

Transport Network's Planning and Social Impacts

Transport investment has varied spatial and temporal impacts, including important social distribution impacts, which are increasingly recognized. This session aims to examine the range of social impacts associated with different types of transport investment in different contexts and to derive from this the planning and policy implications.

Topics of Interest

In line with the general call on Transport in a Networked Society our sessions will focus on transport investment, the usage of new infrastructure, developmental impacts, physical and virtual interaction and spatial distribution of these impacts.

Topics of interest include:

- Theory and concepts of social equity and social justice in transport
- Case studies of social justice in transport
- Networks and social justice
- Applying social capital, motility and/or the Capabilities Approach in transport
- Measurement of capabilities or related concepts in transport
- Developmental impacts of transport investment and spatial dimensions
- The network society and improving social justice in transport
- Virtual interaction and substitution effects -spatial dimensions
- Evaluation of social impacts from investment in transport
