Call for papers for the thematic session of Cluster 6 - Accessibility

Accessibility: territorial and socio-economic disparities

Accessibility was first defined by Hansen (1959) as the potential of opportunity for interaction. Since then, numerous studies have proposed different indicators to analyze not only how accessibility differs in the territory but also in a more micro-scale how different socio-economic segments are affected by the provision networks. This session aims to further explore how the basic components of accessibility studies, namely opportunities, territory, time, and impedance are affected by the explosion of new technologies that highly affect the opportunities of spatial interaction.

Topics of Interest

In line with the general call on Transport in a Networked Society, our sessions will focus on how the accessibility indicators can be extended to analyze how networks affect the territorial cohesion and/or the citizens' life. Topics of interest include:

- Territorial cohesion and accessibility. A tale of two cities: "Fairness" and "Efficiency".
- Network efficiency vs accessibility indicators. What-if empirical exercises.
- The borders and their effect on transport impedances and accessibility
- Understanding the role of critical elements: Re-thinking vulnerability, resilience, disruption, connectivity and accessibility concepts.
- Smart territories and inequalities in transport accessibility
- The impacts of ICT and the new sharing-economy schemes on accessibility.

Deadline for abstract submission: 30 January 2017.
