NECTAR PHD award 2022

At the NECTAR international conference in Toronto, the fourth NECTAR PhD Award will be awarded for the best recent PhD thesis work in the NECTAR field. PhD thesis work can be submitted by a PhD supervisor who is a running NECTAR member. We will consider PhD theses which have been or will be defended between July 2019 and June 2022. To be considered, the PhD thesis should be in the general realm of NECTAR research, including topics from the fields of regional economics, urban economics, urban/regional planning, geography, transport planning and transport engineering. The author of the winning paper is expected to present the research at the plenary closing session at the Toronto conference. The winner will receive a reimbursement for travel and accommodation cost for the conference.

2021 NECTAR activities

Cluster 1, Transport Infrastructure Impacts and Evaluation, organized a one day online cluster workshop on Critical Discourses on Transport and Urban Development on 15 June 2021. The workshop was hosted by Robin Hickman (Cluster 1 co-chair) and Christine Hannigan from UCL. The workshop aimed to present and discuss contributions to a new NECTAR volume in the Edward Elgar series. The aim of the edited book is to draw on the use of discourse analysis in transport and urban development, theoretically or through case study analysis, critically engaging with an understanding of the different viewpoints evident in sometimes controversial new projects. The workshop comprised 20 presentations on draft book chapters, each addressing discourse analysis in relation to transport and urban development from a particular angle or viewpoint. After the workshop, draft book chapters have been submitted and reviewed. Contributors are currently working on the final versions of their chapters and the book is expected to be published end 2022.

Cluster 6 co-chair Ahmed El-Geneidy (McGill University), Cecilia Silva (University of Oporto) and Karst Geurs (University of Twente) organized and moderated two special Accessibility sessions with 6 papers at the World Symposium of Transport and Land and Use Research (WSTLUR). The conference was held virtually August 9-11, 2021, hosted by Portland State University in Portland, Oregon, USA.

Transport in Human Scale Cities



The 9th volume "Transport in Human Scale Cities" in the NECTAR book series has been published by Edward Elgar in September 2021. This is the first NECTAR book in the Edward Elgar series which has been made available as open access. The book calls for a paradigm shift in urban transport, which remains one of the critically uncertain aspects of the sustainability transformation of our societies. The book brings together contributions from the 15th biennial NECTAR conference "Human Scale Cities: Open and Happy" organized at the University of Helsinki, June 5-7, 2019, and other invited contributions. The book is edited by Miloš Mladenović (Aalto University), Tuuli Toivonen (University of Helsinki), Elias Willberg (University of Helsinki) and Karst Geurs (University of Twente).
